COVID-19 Pandemic Will Disrupt Cancer Reporting for Years to Come

New research from the ACS outlines significant ways that the COVID-19 pandemic destabilized usual patterns of cancer care as reported in the National Cancer Database (NCDB). The research, <u>published in JAMA Surgery</u> as a Special Communication article, describes specific ways that NCDB data models were impacted by the pandemic, offering guidance to centers across the country on how to interpret data from 2020 and onwards. The research also paints a much larger picture of the many disruptions caused by the pandemic outside of the immediate emergency of treating COVID-19 patients. Read more

CoC Releases Standards Update

On February 27 the CoC released the latest update to its 2020 accreditation standards, *Optimal Resources for Cancer Care (2020 Standards)*. The updated standards and changelog documenting the standards revisions made in this release are available for download on the CoC website. *Optimal Resources for Cancer Care (2020 Standards)* has been revised to provide the most recent updates to language and terminology for CoC accreditation, clarification edits, and updated compliance measures for Standard 3.2 and Standard 5.1. REMINDER: New Standards In Effect for Networks and Pediatric Programs

Starting this year, the revised standards for Integrated Network Cancer Programs (INCPs) and National Cancer Institute Networks (NCINs) are now in effect. Pediatric Cancer Programs (PCPs) also have updated requirements. Details of the updated requirements may be found in the Specifications by Category section of *Optimal Resources for Cancer Care (2020 Standards)*.

New Resources for CoC Standards 5.7 and 5.8

The Cancer Surgery Standards Program has developed one-page informational flyers that detail the technical and compliance requirements for CoC Standard 5.7 (Total Mesorectal Excision) and CoC Standard 5.8 (Pulmonary Resection). Each flyer includes a QR code that directs the viewer to the Operative Standards Toolkit, where they can find educational resources related to the standards. We encourage staff at CoC accredited cancer programs to email the flyers to surgeons at their sites or print copies to post where surgeons might view them (e.g., surgery lounges, locker rooms, etc.).
