#### The AJCC is the standard setter for cancer staging

- Anatomic staging (TNM staging) is at the core of cancer staging
- Rapid advancements in cancer care provide significant opportunity to better define prognosis and treatment at the individual level (personalized medicine)
- AJCC's role is crucial to cancer care, surveillance, research and patient advocacy
- AJCC publications and other offerings serve as the authoritative guide for cancer staging and serve thousands of medical professionals across the entire continuum of cancer care





#### The Cancer Staging Manual has been re-branded as the "Cancer Staging System" and will be released on an annual basis

- Previous editions released every 5-7 years as 'Cancer Staging Manuals' with all disease sites updated at one time
- Cancer Staging System Version 9 will replace the 8<sup>th</sup> Edition
- Disease sites will be released on an individual basis based on the needs of the cancer care community
- The goal is to ensure that cancer staging is current, evidence-based and meets the needs of the patient care and surveillance communities
- First disease site released in October 2020 (Cancer Staging System for the Cervix Uteri)
- Several other disease sites in the process of revision





#### Unlike previous edition of the Cancer Staging Manual, the Cancer Staging System has gone digital

- Cervix Uteri disease site released as e-book with on-demand paperback copy available for purchase
- Library services and content aggregators will be adding Version 9 to existing AJCC content
- Application Program Interfaces (API) are available for both the clinical and registry environments to allow for rapid integration of updated staging information into EHR and registry databases
- Additional digital tools: The AJCC has established an Implementation Committee to facilitate stakeholder engagement and input on additional digital tools





#### New and updated Disease Site protocols will be more streamlined, user friendly and with significant stakeholder input/involvement

- Editorial Board structure revamped and revised to allow for extensive stakeholder involvement and input
- More stringent levels of evidence implemented for changes to staging
- Terminology harmonized with other standard setting and stakeholder organizations to facilitate standardization across cancer care continuum
- Disease site protocols include:
  - Easy-to-use clinical and pathologic TNM staging tables tailored for use by a broad setting of stakeholder communities
  - Risk assessment tools, prognostic factors, registry collection variables and others





### The 8<sup>th</sup> Edition of the Cancer Staging Manual will continue to be used for staging and cancer surveillance until new disease sites are available with Version 9

- As Disease Sites are individually released over the next several years, they will replace the corresponding chapters in the 8<sup>th</sup> Edition
- Until the release of all Disease Sites in Version 9 is complete, the relevant chapters in the 8<sup>th</sup> Edition will <u>continue to be used</u> for clinical care and by the surveillance community
- The AJCC will work with stakeholders to widely communicate this with the cancer care community







- The Cancer Staging Manual re-branded as the "Cancer Staging System"
- Individual Disease Site Protocols (previously referred to as chapters) are being released on a regular basis
- Cervix Uteri available with other disease sites in the queue for release
- The Cancer Staging System has several digital products including e-book and APIs with more products to follow
- New and updated Disease Site protocols will be more streamlined, user friendly and with significant stakeholder input and involvement
- The Eighth Edition of the Cancer Staging Manual will continue to be used until new disease sites are available with Version 9
