The following are a few recent updates that I hope you'll find useful in your role as the CLP for your program.

ACS Launches New Quality Campaign

The American College of Surgeons (ACS) has launched the Power of Quality campaign—a national, multiyear campaign aimed at improving patient care by expanding the reach of ACS Quality Programs to more hospitals nationwide. These evidence-based programs improve patient outcomes, streamline hospital processes, and lower costs. Working closely with hospitals and surgeons, the ACS will also promote policy frameworks and incentives that keep quality at the forefront of patient care. Read more.

CoC Hosts Spring Meeting

The CoC hosted its Annual Spring Meeting in Chicago in May. Members received updates on the ACS Quality Campaign, National Cancer Database (NCDB), surgical standards, ACS Cancer Research Program evaluation of CoC standards, and CoC structural and committee changes. The morning breakout session discussions focused on the value of CoC accreditation to patients and the public, healthcare providers, hospital administrators, and payors and regulators. In the afternoon, members learned about ACS efforts to promote diversity, equity, and inclusion, and again broke into small groups to discuss strategies for increasing equitable access to cancer care in all communities.

Dr. Mullett Joins Cancer Moonshot Forum

CoC Chair **Timothy W. Mullett, MD, MBA, FACS**, recently participated in a <u>forum</u> hosted by the White House focused on expanding equitable access to smoking cessation programs. The event was part of

President Biden's <u>Cancer Moonshot</u> initiative, which includes efforts to reduce the burden of preventable cancers, including tobacco-related cancers.

ACS Cancer Programs has launched a series of national QI initiatives to address smoking status and cessation. The 2022 <u>Just ASK</u> QI project and clinical study focused on leveraging existing resources, by asking all newly diagnosed cancer patients about their smoking status. The 2023 <u>Beyond ASK</u> QI project is seeking to build the capacity of participating programs to offer cessation assistance to newly diagnosed cancer patients.

CoC Announces Standards Updates

The CoC has released an updated version of its accreditation standards, <u>Optimal Resources for Cancer Care (2020 Standards)</u>. The updated standards and the <u>change log</u> documenting the revisions are now available on the CoC website.

Pediatric Program Standards

The Pediatric Cancer Program (PCP) standards have been updated to add guidance and clarifications. Updates apply to both standalone PCPs, and programs adding a secondary pediatric accreditation category to an existing CoC accreditation.

Standard 5.1: College of American Pathologists Synoptic Reporting

The internal audit requirement for Standard 5.1 has been updated to clarify that each calendar year the internal audit must evaluate a minimum of 20 total surgical resection cases. The selected cases must include at least three different disease sites. Programs must meet compliance with the revised standard beginning January 1, 2024.

As previously announced, Standard 5.1 is not being evaluated for compliance during site visits conducted in 2023 or 2024. Starting in 2025, all future site visits will only evaluate compliance with Standard 5.1 for calendar year 2024 and beyond.

Standard 4.2: Oncology Nursing Credentials

Effective immediately, per diem nurses who work less than 832 hours each calendar year are not required to demonstrate compliance with Standard 4.2. Per diem nurses who work 832 hours or more each calendar year must meet the standard as written. This information has been included in an updated Frequently Asked Questions (FAQ) document, located in the CoC Standards Resource Library, available through the ACS Quality Portal.

Qualified candidates for the CoC must be actively practicing physicians who specialize in cancer care and are employed or affiliated with a CoC-accredited program.
