Governor Signs Executive Order Creating Healthcare Workforce Task Force

Wyoming Governor Mark Gordon (R) signed an <u>executive order</u> on February 29 creating the task force charged with making recommendations to streamline the health care licensing process, establish health care educational avenues, and ensuring reimbursement for those professionals.

STATUS OF LEGISLATIVE SESSIONS

The following state legislatures have adjourned: Florida, Idaho, Indiana, New Mexico, Oregon, Utah, Virginia, Washington, West Virginia, Wisconsin, and Wyoming. Montana, Nevada, North Dakota, and Texas have no regular session in even-numbered years. Legislative session information can be found here.

LEGISLATIVE TRACKING

ALABAMA

SB 236 – Certificate of Need

Introduced by Senator Larry Stutts (R), SB 236 eliminates the certificate of need requirement for any proposed new or expanded medical facility or health care service located in a rural area. The bill was introduced in the Senate and is pending referral to a committee.

ARKANSAS - ENACTED

HB 1271 – Prior Authorization

Introduced by Representative Lee Johnson (R), HB 1271 requires healthcare insurers to evaluate whether providers still qualify for exemptions from prior authorization requirements. Governor Sarah Huckabee Sanders (R) signed the bill into law April 11.

CALIFORNIA

SB 516 – Prior Authorization

Introduced by Senator Nancy Skinner (D), SB 516 removes unnecessary prior authorizations; streamlines the process for submitting and appealing a prior authorization request; provides transparency and data on health plan actions; requires a physician of the same or similar specialty to conduct appeals of a prior authorization denial. The bill was introduced and referred to the governance and Finance Committee.

COLORADO

HB 1153 – Licensure

Introduced by Representative Lorena Garcia (D), HB 1153 establishes a continuing education requirement for physicians in the state; 40 hours in the 24 months preceding license renewal, reinstatement, or reactivation of a license; the board will do random audits to enforce compliance. The bill was introduced in the House and referred to the Health and Human Services Committee.

IDAHO

H 505 – Licensure ENACTED

Introduced by the House Business Committee, H 505 extends the physician licensure renewal from one year to two years. Governor Brad Little (R) signed the bill into law March 18.

IOWA

HF 2668 – Biomarker

Introduced by the House Appropriations Committee, HF 2668 requires health insurance policies to cover biomarker testing for diagnosing, treating, managing, or monitoring a disease or condition in covered individuals when the test has demonstrated clinical utility. The bill was introduced in the House and is pending referral to a committee.

KANSAS

SB 233 – Criminalization/Liability

Introduced by the Federal and State Affairs Committee, SB 233 authorizes a civil cause of action against healthcare providers for providing gender-transitioning care to children; requires professional discipline against a healthcare provider who performs such treatment; prohibits professional liability insurance from covering damages for healthcare providers who provide gender transition treatment to children. The bill was introduced in the House and referred to the Public Health and Welfare Committee.

LOUISIANA - ENACTED

SB 110 – Prior Authorization

Introduced by Senator Kirk Talbot (R), SB 110 requires insures offer expedited review of prior authorization requests related to the diagnosis or treatment of cancer and respond within two business days. Governor Jeff Landry (R) signed the bill into law June 12.

HB 742 – Professional Liability

Introduced by Representative Denise Marcelle (D), HB 742 mandates no physician who acts in good faith in the screening, collection, conservation, preparation, transfer, or cryopreservation of the human ovum fertilized in vitro for transfer to the human uterus shall be subject to criminal prosecution or civil liability. The bill was introduced in the House and is pending referral to a committee.

MAINE

LD 2271 – Telehealth

Introduced by Senator Donna Bailey (D), LD 2271 prohibits a healthcare entity from charging a facility fee for telehealth services unless the patient is physically present in a hospital-based facility when receiving those telehealth services. The bill was introduced in the Senate and referred to the Joint Standing Health Coverage Committee.

MARYLAND

SB 13 – Cancer

Introduced by Senator Michael Jackson (D), SB 13 requires the Pediatric Cancer Fund be used only for pediatric cancer research instead of pediatric cancer research, prevention, and treatment. The bill was introduced in the Senate and referred to the Finance Committee.

MINNESOTA

HF 1658 – Insurance/Cancer

Introduced by Representative Jeff Brand (D), HF 1658 mandates infertility treatment coverage by health plans and medical assistance, including fertility preservation procedures for cancer

patients. The bill was introduced in the House and referred to the Commerce Finance and Policy Committee.

HF 4945 – Workplace Violence

Introduced by Representative John Huot (D), HF 4945 increases the penalty for assaulting health care providers to a felony; potential to be sentenced to imprisonment for not more than three years or to payment of a fine of not more than \$6,000, or both if the assault inflicts demonstrable bodily harm. The bill was introduced in the House and referred to the Public Safety Finance and Policy Committee.

SF 5138 – Workplace Violence

Introduced by Senator Bill Lieske (R), mandates whoever physically assaults and inflicts demonstrable bodily harm onto a physician or nurse is guilty of a felony and may be sentenced to imprisonment for not more than two years or to payment of a fine of not more than \$4,000, or both. The bill was introduced in the Senate and referred to the Judiciary and Public Safety Committee.

MISSISSIPPI

SC 539 – Trauma

Introduced by Senator Walter Michel (R), SC 539 designates March 2024 as Brain Injury Awareness Month to promote the awareness of acquired brain injuries. The resolution was introduced in the Senate and referred to the Rules Committee.

NEW JERSEY

S 2988 – Telehealth

Introduced by Senator Vin Gopal (D), S 2988 mandates health benefit plans provide coverage and payment parity for health care services delivered to a covered person through telemedicine. The bill was introduced in the Senate and referred to the Commerce Committee.

S 3060 - Cancer

Introduced by Senator Troy Singelton (D), S 3060 provides for no cost sharing prostate cancer screening. The bill was introduced in the Senate and is pending referral to a committee.

OHIO

HB 452 – Workplace Violence

Introduced by Representative Andrea White (R), HB 452 requires each hospital system to establish a security plan for preventing workplace violence and managing aggressive behaviors; the plan must involve a team that includes its health care employees who provide direct patient care. The bill was introduced in the House and is pending referral to a committee.

OKLAHOMA

HB 3214 – Professional Liability

Introduced by Representative Kevin West (R), HB 3214 mandates medical practitioners have the right not to participate in a health care service that violates their conscience; a medical practitioner's refusal to participate in a health care service based on an exercise of conscience may not be a basis for discrimination, discipline, or other recriminatory action against the

medical practitioner. The bill was introduced in the House and referred to the Public Health Committee.

RHODE ISLAND

<u>H 8072</u> – Payment

Introduced by Representative Teresa Tanzi (D), H 8072 mandates health insurers must ensure contracts with hospitals and healthcare providers pay at least the regional average rate. The bill was introduced in the House and referred to the Health and Human Services Committee.

H 8073 – Cancer

Introduced by Representative Kathleen Fogarty (D), HB 8073 mandates health insurance plans issued in the state provide coverage for the use of artificial intelligence technology for analysis of breast tissue diagnostic imaging, provided the breast tissue diagnostic imaging and the review generated by artificial intelligence is independently reviewed and approved of by a physician qualified to read and interpret breast tissue diagnostic imaging. The bill was introduced in the House and referred to the Health and Human Services Committee.

H 8074 – Scope of Practice

Introduced by Representative Edward Cardillo (R), H 8074 removes the requirement to obtain a referral from a primary care provider in order to see a specialist. The bill was introduced in the House and referred to the Health and Human Services Committee.

VERMONT

HCR 177 – Cancer - ADOPTED

Introduced by Representative Kate McCann (D), HCR 177 recognizes March as Colorectal Cancer Awareness Month. The resolution was introduced in the House and adopted on March 15.

WASHINGTON

HB 2041 – Scope of Practice ENACTED

Introduced by Representative Marcus Riccelli (D), HB 2041 allows a physician assistant (PA) who has completed 4,000 hours of postgraduate clinical practice to practice without a collaborative agreement with a physician; provisions for 2,000 additional hours under collaboration with a physician if the PA chooses to change specialties. Governor Phil Murphy (D) signed the bill into law on March 13.

WISCONSIN

AB 954 – Licensure

Introduced by Representative Calvin Callahan (R), AB 954 creates provisional licenses for internationally trained physicians to practice as a physician within the state; provisional licenses to practice as a physician are automatically converted into permanent licenses after the provisional license holder practices in this state and maintains good standing for three consecutive years. The bill was introduced in the Assembly and referred to the Health, Aging and Long-Term Care Committee.
