# ACS Geriatric Surgery Verification Program Comprehensive & Focused Level Site Visit Agenda Overview



The verification site visit process aims to confirm a hospital's adherence with the GSV standards. Site Reviewers conduct a focused evaluation of a hospital by conducting a chart review, assessing their processes and protocols, and engaging with team members to fully understand their workflows. During the site visit, a designated hospital staff member must be available to address any inquiries. Reviewers may also request additional information and documentation beyond the initially requested documents if further evidence of compliance with the standards is needed.
