Dear Speaker Pelosi and Leaders Schumer, McConnell, and McCarthy:

On behalf of the undersigned chapters representing Fellows of the American College of Surgeons (ACS), we appreciate Congress' past efforts to delay the impact of Medicare payment cuts, providing reprieve during a time of significant instability. However, without congressional intervention surgeons, other physicians, and health care professionals will receive significant cuts of nearly 8.5% in Medicare payment on January 1, 2023.

The 2023 Medicare Physician Fee Schedule (MPFS) Proposed Rule once again jeopardizes the financial stability of many physician practices by proposing policies that will lead to approximately 4.5 percent in cuts to Medicare payment. These cuts, combined with the pending threat of the 4 percent PAYGO reduction, are simply not sustainable. As proposed, these cuts would be on top of the 2 percent sequestration cuts implemented in 2022 and the lowest level conversion factor since 1994. With no mechanism in place to bring payment levels to the current cost of providing care, these compounding negative financial factors facing those who treat Medicare patients co-exist amid historically high inflation. While true transformation will require significant collaboration and investment, the ACS remains committed to partnering with Congress to establish a pathway for identifying policy solutions to ensure long-term stability for the MPFS while identifying and advancing other necessary reforms.

In addition to staving off these immediate cuts, the legislation should also provide a one-year inflationary update based on the Medicare Economic Index.
