






What is your NAPRC role?





How do you notify your pathology department of an upcoming case?





Where are pictures of rectal cancer specimens being taken?








Where are the photos being uploaded?


How is the mesorectal grade and distal margin conveyed?




Operating Room Procedure for Pathology

Medical Photographer Procedure

VMMC Policy and Procedures (std X.Y)

- Photograph all rectal cancer specimens using Medical Photography services as follows and upload to PicsPlus:
 - Un-inked anterior, posterior, and lateral views prior to opening to demonstrate completeness of mesorectal envelope.
 - Open specimen demonstrating tumor and relevant structures/margins.
- Any requested colon resection indicated by surgeon for Medical Photography, employ Medical Photography services and upload to PicsPlus.
 - Un-inked intact and open views.
- All other colon specimen photos can be taken by the Surgical Pathology team and uploaded to PicsPlus for documentation.

POLICY & GUIDELINES

Photographs of the fresh or formalin fixed ex-vivo specimen may be obtained using any standard digital camera in either the operating room or in the pathology laboratory. These images are shown and discussed at Rectal Cancer Multidisciplinary Team (RC-MDT) meetings and are electronically stored with a patient

A minimum of 65% of all eligible surgical specimens must be photographed:

- Include four views: anterior, posterior, and two lateral views
- Presented to and discussed by the RC-MDT and electronically stored with the patient identifier.

If the specimen is photographed but not presented and discussed at an RC MDT meeting, then it does not qualify for the 65% required for compliance with this standard.


- Photograph all rectal cancer specimens using Medical Photography services as follows and
 - Un inked anterior, posterior, and lateral views prior to opening to demonstrate completeness of mesorectal envelope.
 - Open specimen demonstrating tumor and relevant structures/margins
- Any requested color resection indicated by surgion for Medical Photography, employ Medical. Photography services and upload to PicsPlus.
 - Uninked intact and open views.
- All other colon specimen photos can be taken by the Surgical Pathology team and uploaded to PiesPlus for documentation

Virginia Mason Internal Medical Record Review

At a minimum, a random sample of 20 percent of eligible patient medical records or a maximum of 100 cases will be reviewed by the Rectal Cancer Program (RCP) Director each calendar year to evaluate compliance with this standard. The RCP Director may delegate this review to an appropriately

Tumor Board Pathology Photos Presentation










- Anterior, posterior, and two lateral views presented with the pathology during Post-Op Tumor Board presentation
 - Grade of the TME discussed
- Pathology discussion the proceeds as normal

Protocol implications for other colorectal cancers

- Protocol has extended to all pathology for colorectal tumor board pathology reviews
 - Colon and Anal cases discussed and documented in the same way



- Challenges / Opportunities ahead
 - Cases that finish "after hours"
 - Standardizing path presentation of photos?
 - Photos sent to patients / referring providers
